Cheneae is currently the Managing Director for Little Beach Harvest, which is the Cannabis business wholly owned by the Shinnecock Nation. She is a recent published author of a book titled “50 Plant Medicines: Indigenous Oral History & Perspective” She wrote the book to help share her own medicine to help readers in their journey to learn more about the plant medicines that have been used for thousands of years.



Little Beach Harvest LLC (“Little Beach”) is a vertically integrated cannabis company operating the Shinnecock Nation’s cannabis business under tribal law passed in 2016. Little Beach is licensed and regulated by the Shinnecock Cannabis Regulatory Division.

Little Beach is constructing a full cultivation and processing facility, along with a modern dispensary including a drive-through, and an adjacent lounge in on Shinnecock Territory –a truly unique cannabis destination in the Hamptons. Little Beach is fostering well-being and health through plant medicine, bringing indigenous culture, history, and herbal remedies into modern times.

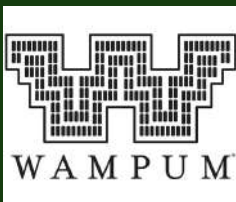

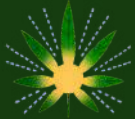

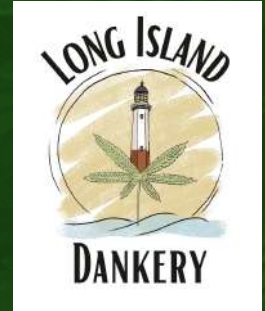
